Stallion Breeding Contract

I, _____, hereby agree on this _____ day of _____, in the year _____, to breed the mare named below to, **Scotch N Chips/ Hot Scotch Chips** (APHA Reg # 917055 AQHA Reg # 4983898 DNA Type QH _____) for the 20____ season subject to the following conditions:

1. The stallion fee is \$400.00, including a non-refundable booking fee of \$150.00, which shall be payable upon execution of this contract. The balance of the breeding fee shall be paid on or before the day the above mentioned mare is picked up from the facility of Zavaduk Quarter Horses (Trevor & Shannon Zavaduk) of Moose Jaw, SK. All other expenses, including board and veterinary expenses shall be paid in full before the above mentioned mare is released.
2. Zavaduk Quarter Horses (Trevor & Shannon Zavaduk) agrees to provide suitable care and feeding for the mare and/or foal while at their facility. The mare owner agrees to pay \$8.00 per day dry or \$12.00 per day wet.
3. Zavaduk Quarter Horses (Trevor & Shannon Zavaduk) will exercise judgment in the care and supervision of your mare. A veterinarian will administer medical care as deemed necessary for the health and safety of the mare. Mare owner hereby consents to **all** medical care administered to the mare by veterinarian as well as all farrier expenses.
4. The mare shall be in healthy and sound breeding condition: free from infections, contagious and transmittable disease. **All mares** other than maiden mares will require a clean culture, with results presented prior to breeding. **All mares** are required to have a current coggins test with results presented **prior to arrival** on farm. A photo stat copy of registration papers is also required.
5. Zavaduk Quarter Horses (Trevor & Shannon Zavaduk) agrees to diligently try to settle owner's mare. Mare owner agrees to give Zavaduk Quarter Horses (Trevor & Shannon Zavaduk) ample opportunity to settle the mare (having bred her through at least two heat cycles).
6. This contract contains a "LIVE FOAL/LIVE COLORED FOAL GUARANTEE."
 - a) A live foal is described as a newborn foal, which stands and nurses without assistance. If the foal is born dead, a return breeding privilege shall apply, including lethal white foal. Return breeding privileges apply **only** to the following breeding season. A substitute mare may be sent if the original mare is deceased or deemed unfit for breeding or an alternate mare agreed upon by both parties. The "LIVE FOAL GUARANTEE" in this contract is non-transferable and non-assignable. Should the mare be sold or otherwise disposed of prior to the birth of the foal, the "LIVE FOAL GUARANTEE" shall be void

b) A live colored foal is described as a newborn foal which has enough white to qualify for Regular Registry within it's deemed association, which stands and nurses without assistance. If the foal is born dead, a return breeding privilege shall apply, including lethal white foal. Return breeding privileges apply **only** to the following breeding season. A substitute mare may be sent if the original mare is deceased or deemed unfit for breeding or an alternate mare agreed upon by both parties. The "LIVE COLORED FOAL GUARANTEE" in this contract is non-transferable and non-assignable. Should the mare be sold or otherwise disposed of prior to the birth of the foal, the "LIVE COLORED FOAL GUARANTEE" shall be void.

c) A live foal guarantee is **ONLY** valid if the mare remains on farm to be checked back through a second heat cycle. Should the mare owner choose to pay any outstanding amounts owing and remove the mare from the property prior to the second cycle, the "LIVE FOAL GUARANTEE" shall be void.

7. A Breeders Certificate will be issued/released to the mare owner when Zavaduk Quarter Horses (Trevor & Shannon Zavaduk) have been notified that a live foal/colored foal has been produced.
8. Zavaduk Quarter Horses (Trevor & Shannon Zavaduk), employees or agents thereof, shall not be liable for the death, sickness and/or accident to the mare and/or foal.
9. Should the stallion die or become unfit for service for any reason this contract shall become null and void and all parties are relieved from further obligation.
10. All fee stated above must have 7% GST added.
